### A MESSAGE FROM OUR LEADERSHIP

Dear Friends,

The past two years have been a time of learning, adapting, growing and connecting at KIAC. Like many organizations in the face of Covid-19, KIAC went remote in March 2020 with a hybridization of services to follow. Thanks to a committed base of staff, volunteers and organizational partners, <u>we served nearly double the number of immigrants in 2021 compared to what we did pre-pandemic.</u>

During this period, we continued evolving to bring those we serve onto our team — as staff, volunteers and members of KIAC's Board of Directors. There has been a growing interest from members of the communities we serve — youth and adults — in volunteering and connecting KIAC with those who need our services. We will continue this evolution in 2022.

Our reputation as the trusted hub for immigrants in the West Puget Sound Region grows, and the number of clients seeking KIAC's services reflects that growth. The demand for our services continues to outpace what we are able to do with our current resources. An important goal for KIAC in 2022 and beyond is to continue investing in our team — hiring additional staff members, recruiting more volunteers, and offering wages and benefits that encourage staff retention.

KIAC couldn't do this work without our community of supporters. We thank you, our volunteers, donors and organizational partners, for the many ways you contribute to KIAC's mission. We look forward to what our collective efforts will do for KIAC and our immigrant neighbors in the coming year.

### KIAC's Mission & Vision



## HOW KIAC WORKS


KIAC operates with a lean staff team overseeing a group of dedicated volunteers.


